Action Alternatives:

1. You have checked the references and they were fine. The folks you talked to are reasonable and had direct knowledge of the consultant's work. You do not want to appear to be looking to make trouble for yourself or anyone else. You decide no further action is necessary.

2. When spending public money, you have a responsibility to make sure that the public will get the best value.

This requires you to be zealous in determining whether there are any reasons for not hiring the consulting firm.

After all, consulting firms do not ever list clients who they think might give them a bad reference. You call for references checking with names not on the list provided by the firm.
